An Easy, Safe Way to Hold Money for a Minor

What Are Custodial Accounts?

These special savings accounts are ideal for holding money that has been given to a minor. The donor, who opens and funds the account, chooses a custodian¹ who "holds" the money for the minor in this special account, typically until the minor turns 18.

Please Note: Custodial accounts are not representative payee accounts, which Navy Federal Credit Union does not offer.

Why Choose a Custodial Account?

Custodial accounts are safe, easy ways to save money for a minor.² The accounts can receive insurance coverage of up to \$250,000 and require no legal fees. Custodial accounts are insured separately from the minor's other Navy Federal accounts and from the custodian's Navy Federal accounts.

How to Open an Account

To open an account, the donor and the custodian¹ need to complete a Custodial Account application (Form #176). You'll need the name and Social Security number of the minor. The minor must be a member with an active Share Savings Account. As long as each account has a different custodian, a minor may have multiple custodial accounts.³



Donor Responsibilities

The donor is the person who provides the funds and appoints the custodian.¹ Donor funds are irrevocable, are not tax-deductible and can only be made during the donor's lifetime.

Custodial Responsibilities

The custodian manages how the funds are utilized once the account is opened. The custodian is the only signature holder on the account and the only person who can perform transactions on the account, which can only be used for the benefit of the minor. Funds may be placed in a Navy Federal savings or certificate account. The custodian is responsible for transferring the funds to the minor. This can be done in writing, by visiting a branch or by calling 1-888-842-6328.
